RULES OF REGISTRATION

- 1. Upon registration a learner is bound and cannot cancel the registration unless it is cancelled by the Academic Director and a fee of 50% will be charged on registration fees.
- 2. If a learner stops attending classes for reasons unknown, he / she will be liable for the full payment of fees unless a notice is made in writing within 7 working days of the first month of attendance. Should 3 months of non-attendance pass, all payments will be forfeited.
- 3. A non-refundable registration fee is payable on all courses.
- 4. Learners may not start attending classes until the deposit and first instalment stated on the course is paid.
- 5. Cosmetology Beauty College reserves the right to admit a learner in the institute respectively.
- 6. As a training provider, all short skills courses offered are Seta accredited in association with Gautech Training Institute.
- 7. Learners will not be allowed to attend classes with outstanding fees for the respective month or any arrangements with the institute.
- 8. Cosmetology Beauty College has no refund process on payments paid whether in cash or bank payments.
- 9. No cash is permitted on the premises except registration and learning material fees.
